Foreword

Beginning in 2014 – and with the ongoing support and vision of U.S. Senator Lindsay Graham - the U.S. Department of State's Bureau of International Narcotics and Law Enforcement Affairs (DOS/INL) managed the Justice Sector Training, Research, and Coordination Program (JUSTRAC) in partnership with the Rule of Law Collaborative at the University of South Carolina (ROLC).

The aim of JUSTRAC was to build knowledge and skills while strengthening coordination across the U.S. Government interagency. JUSTRAC was focused on those engaged in rule of law programming for the benefit of recipients of U.S. foreign assistance in developing, transitional, and post-conflict states. This report summarizes the accomplishments of JUSTRAC as its five-year mandate comes to an end.

Led by Director Joel Samuels, the ROLC team spearheaded the creation of all aspects of the training courses, symposia, website, newsletters, and research described further herein. In addition, ROLC called on members of its extended network to participate in activities over the five years of JUSTRAC and developed particularly strong institutional partnerships with the American Bar Association Rule of Law Initiative (ABA ROLI), the United States Institute of Peace, and the Woodrow Wilson International Center for Scholars. In the years to come, in partnership with ABA ROLI, ROLC will work with DOS/INL to build upon the accomplishments of JUSTRAC through its successor, JUSTRAC+.

Scope & Reach

For the past five years, JUSTRAC has designed and delivered 19 wide-ranging, two-day rule of law and justice sector training courses. These courses attracted over 800 participants from 16 federal agencies and 55 different organizations from around the world.

Offering two tiers of learning — introductory and advanced — JUSTRAC training courses incorporated expert lecturers,

case studies, practitioner panels, and interactive exercises to enhance learning and interagency awareness.

Advanced course topics included a comparative law series examining both Islamic Legal Systems and Civil Law Systems, as well as specialized topics, such as security sector reform and combating corruption.

Program Impact

As assessed through various types of participant surveys, the JUSTRAC training courses have demonstrated an impact in a variety of key areas:

ON JUSTICE SECTOR KNOWLEDGE AND SKILLS:

Immediately after the training, 95% of respondents reported that a JUSTRAC training course increased their skills, knowledge, and information concerning justice sector reform principles and practices. Three months post-training, 75% of respondents reported having applied the skills, knowledge, and information gained in the training to their work.

ON INTERAGENCY CONTACT, COORDINATION, AND COLLABORATION:

Immediately after the training, 89% of respondents reported that a JUSTRAC training course helped them expand their professional network, including 85% who developed a working relationship with at least one participant from a different government agency or organization. Three months post-training, 63% of respondents maintained contact with at least one participant from a different government agency or organization than their own.

Scope & Reach

For the past five years, JUSTRAC designed and delivered 15 symposia that engaged practitioners in a deeper analysis of specialized topics in rule of law reform. These symposia have attracted nearly 1,100 participants from 14 federal agencies and over 300 organizations around the world. Nine symposia were convened in Washington, D.C., while six were held abroad.

DOMESTIC SYMPOSIA

JUSTRAC's domestic symposia typically included keynote addresses and panel discussions characterized by engaging, moderator-led conversations among experts on a range of topics of interest to the justice sector and rule of law reform community.

INTERNATIONAL SYMPOSIA

JUSTRAC's international symposia, which were designed and delivered throughout the world, were composed of key experts and professionals from particular regions who participated in plenary roundtable discussions and smaller working group sessions. These working groups were designed to generate specific recommendations on pressing rule of law topics. The recommendations were incorporated into White Papers that were disseminated across the U.S. Government and to symposium participants; they are also available to the public on the JUSTRAC website.

Program Impact

As assessed through various types of participant surveys, the JUSTRAC symposia have demonstrated an impact in a variety of key areas:

ON JUSTICE SECTOR KNOWLEDGE AND SKILLS:

Immediately after the symposium, 92% of respondents reported that a JUSTRAC symposium increased their skills, knowledge, and information on sector reform principles and justice practices. Three months after the event, 59% of respondents reported having actually applied the skills, knowledge, and information gained in the symposium to their daily work.

ON INTERAGENCY CONTACT, COORDINATION, AND **COLLABORATION:**

Immediately after the symposium, 78% of respondents reported that a JUSTRAC symposium positioned them to establish contact with another person from the event, and 69% of respondents established contact with a participant from a different government agency or organization than their own.

Three months after the symposium, 79% of respondents coordinated or collaborated with representatives of agencies of the U.S. Government engaged in justice sector reform and rule of law programs, and 68% of respondents maintained contact with a participant from a different government agency or organization than their own.








Updated on a daily basis, the JUSTRAC website (justrac.org) is a centralized platform for learning and dissemination of timely information about news, research, resources, and opportunities relevant to rule of law and justice sector reform.

With over 25,000 hits since its inception, the JUSTRAC website maintains a robust array of content, including over 90 publication summaries geared toward a practitioner audience, a library of over 400 recommended readings, 15 justice sector reform Practitioner Profiles, over 5,000 news links to rule of law and justice sector issues, and information regarding over 300 programs and solicitations in rule of law and justice sector issues.

The website also serves as the coordination and registration hub for JUSTRAC training courses and symposia.

JUSTRAC has delivered 20 guarterly newsletters with a current mailing list of over 1,400 professionals. The quarterly newsletters include summaries of completed JUSTRAC training courses and symposia, previews of upcoming JUSTRAC events, Practitioner Profiles from around the U.S. Government, timely JUSTRAC developments, and information about other upcoming events and opportunities.







Collaboration & Coordination

Interagency & Multilateral Support

Interagency collaboration was central to the Every JUSTRAC activity sought to engage a design, development, and delivery of every diverse array of speakers and participants. JUSTRAC activity.

JUSTRAC supported priorities and sectoral challenges through an interagency steering committee and a liaison committee comprised of U.S. senior and working-level federal agency representatives and multilateral partners, respectively. These two committees advised the Bureau of International Narcotics and Law Enforcement Affairs on the appropriate activities and priorities for JUSTRAC through a consultative process on trainings, symposia, and research topics.

In order to encourage coordination and collaboration, ROLC used a wide array of tools, including assigned seating that maintain contact after each event. Working ensured an interagency mix at each table with the JUSTRAC liaison committee, ROLC and interactive exercises during training programs, as well as explicit networking opportunities during all JUSTRAC events.

Many of the speakers for JUSTRAC training courses and symposia were drawn from Administration federal agencies and multilateral partners dedicated to justice sector reform and rule of law promotion.

> The vast majority of participants in JUSTRAC training courses and symposia came from U.S. Government agencies and multilateral partners. JUSTRAC furthered its impact by attracting participation from smaller federal government entities, as well as from academia and from nongovernmental and international organizations.

JUSTRAC emphasized the ability of participants to connect with others and to created new opportunities to establish connections among JUSTRAC participants, fostering sustainable collaboration and coordination.



Beyond JUSTRAC: JUSTRAC+

Building upon the successes of JUSTRAC - and through the continued support of Senator Lindsey Graham – the U.S. Department of State's Bureau of International Narcotics and Law Enforcement Affairs lauched JUSTRAC+ in 2018. Implemented by the Rule of Law Collaborative at the University of South Carolina and by the American Bar Association Rule of Law Initiative, JUSTRAC+ will continue to design, develop, and deliver activities focused on working with the U.S. Government to improve the quality of rule of law programming around the world. Specifically, JUSTRAC+ will seek to deepen interagency knowledge and skills development on topics essential to designers and implementers of rule of law programs.

Carrying forward the JUSTRAC legacy, JUSTRAC+ will:

- U.S. Government rule of law community;
- design and mechanisms for measuring justice;
- reform practitioners; and
- Government rule of law programs.
