# U.S. DEPARTMENT OF STATE (INL) JUSTRAC Training: Rule of Law Fundamentals I

## Course Objectives

The Rule of Law defies easy categorization. The rule of law requires more than law and rules and the adjudication thereof; it includes a variety of public administration services, such as providing civil documents or land titles. The rule of law is foundational to the delivery of effective governance. Authoritarian regimes invoke the rule of law to justify suppressing peaceful dissent and democracies laud its value as they struggle with what it means to adhere to it. In its narrowest sense, the rule of law can be a hollow promise to provide human security at the expense of civil liberties. At its most fulsome, the rule of law represents a social compact between public officials and citizens that laws, rules, and their enforcement align with domestic, constitutional and international norms.

The rule of law is also a U.S. constitutional obligation and foreign policy imperative. For those USG staff working on programs and initiatives promoting judicial reform, combating corruption, or elevating international standards, a rich, nuanced understanding of what rule of law means is fundamental. Core skills for effective engagement on the rule of law include understanding definitions and principles related to the rule of law, recognizing how different legal traditions affect concepts of adherence, and being able to identify elements, roles, and needed capacities of rule of law institutions to uphold rule of law principles.

This two-day training course will begin with an overview of the different legal systems, how they operate, and the various justice sector actors, including civil society, that interact with each other and contribute to the rule of law. Participants will learn to identify system strengths and weaknesses that may support or undermine adherence to international rule of law standards. They will engage with the role of human rights legal instruments, how they are enforced domestically, and how international diplomacy and dialogue contribute to the rule of law. Participants will also explore how legal systems incorporate customs, practices, and social norms into informal mechanisms to pursue rule of law adherence.

Identifying the institutional actors and socio-political norms contributing to “the rule of law” is just the beginning. Participants will explore how such local systems interact and incorporate undesirable efficiencies, such as corrupt practices, that complicate institutional development efforts. Participants will learn how civil society and other non-justice actors play pivotal roles in efforts to protect and promote the rule of law. Participants will also engage with the importance of human rights and social inclusion when developing rule of law programming. Finally, participants will explore programming basics and addressing them in a rule of law project context, including what constitutes evidence of change, the role of experts, and fundamentals of program design and monitoring.

#### **RULE OF LAW DEFINITIONS, ATTRIBUTES AND RATIONALES**

The concept of thick and thin definitions of the rule of law will be explored, including their relationship to rule of law as a U.S. foreign policy and national security strategy. The session will provide an overview of how separation of powers underscores rule of law, and how certainty, predictability and transparency play vital roles in bolstering adherence to rule of law principles. Participants will be provided historical context so they can appreciate the advancement of rule of law values in emerging democracies.

- Participants will understand different definitions of the rule of law.
- Participants will learn the underlying foundations of a justice system that promotes a healthy rule of law environment.

## **DAY TWO: COMPARATIVE LEGAL TRADITIONS, INTERNATIONAL ENFORCEMENT MECHANISMS AND RULE OF LAW PROGRAMMING**

**Morning Session, October 23, 2024**

**9:00AM – 10:30AM      Integrating International Law into Domestic Legal Frameworks, Promoting Compliance to International Rule of Law Norms and Informal Justice Systems**

Participants will learn about the hierarchy of laws, how treaties and other international covenants and conventions are applied domestically, and the mechanisms to promote compliance with international legal obligations. An overview of informal justice mechanisms will also be provided.

- Participants will understand how informal justice systems resolve conflict, the supremacy of laws, constitutional provisions, and regulatory frameworks, how countries integrate international law into domestic legal systems, and how United Nations mechanisms, including the Universal Periodic Review of Human Rights and the UN Guiding Principles on Business and Human Rights promote adherence to rule of law and human rights standards.
